

The meeting was called to order by the President Mr. Ricardo A. Alkuono, Jr. at 1:05 in the afternoon. It started with a prayer led by Ms. Engracia Lunzaga followed by the singing of the Philippine National Anthem led by Ms. Juanita E. Besoc. A roll call was done by the secretary. There were 44 members present, so there was quorum.

She mentioned that she received one thousand five hundred pesos (P1,500.00) for the tractor rental. Ms. Uy also reminded those who have outstanding balances to pay their obligation.

2. Mortuary

Members of the association are encouraged to pay one hundred pesos (P100.00) per year for mortuary. The said mortuary is not compulsory. The deadline for the mortuary will be on March 14, 2021. In case of casualty the family of the member will received two thousand pesos (P2,000.00).

3. Uniform

It was agreed that the member who won't be able to ware their uniforms during the monthly meeting will be fined twenty pesos (P20.00).

4. Other Matters

- a. Kadiwa Farmers can sell their agricultural produce/harvest at the Kadiwa or Trading Post every Wednesday and Saturday from 8:00AM-5:00PM. There will be no fee collected to the farmers who will sell their products.
- b. Fertilizer Farmers who were able to avail the hybrid rice seeds can now avail their fertilizer allocation at the City Library, Diversion Road.
- c. GAD Budget/Swine Production Project Hon. Gemma Leocadio informed the body that the Swine Production Project proposed for Brgy. Hibunawan will be dispersed to the selected members of the association.

There being no other matters to be discussed, Ms. Imelda Cernias moved for adjournment seconded by Ms. Cristy Derecho. The meeting was adjourned at 2:11 in the afternoon.
