

The meeting was called to order by the President Mr. Gregorio Villaber at 3:30 in the afternoon. All the members of the association were present..

Agenda:

1. Schedule of duty in the layer production project

Mr. Gregorio M. Villaber said that since we have no money yet to pay for our caretaker, two [2] members will be assigned to duty in the layer production project. The activities to be done is to fed the layers, clean the surrounding and harvest the eggs. Collection of chicken dung be done three times a week. Egg collection be done in the morning and in the afternoon. Feeding will be done in the morning and in the afternoon. The president was assigned to deliver the eggs to pannys bakeshop once a week. The association will finance for the gasoline of the motorcycle of the president. The business manager will monitor the water supply and will give the vitamins of the layers. The members on duty will take charge of the sorting/weighing of the eggs.

2. Status of Projects

The president Mr. Gregorio M. VILLABER, said that cooperation is needed in order that the association can continue the operation of the farm. As for the SWINE Production Project, two [2] members are also assigned weekly to take care of our sow and piglets, The assigned on duty will be the one to feed the swine and maintain cleanliness of the sorroundings..

3. Treasurer's report

The president requested the treasurer to present the treasurer's report next meeting.

4. Other Matters

The president said that because most of the members have individual vegetable gardens and they are using the inputs given by PLGU Leyte, the members are required to give to the association ten percent of the net income so that the association can have additional funds. It was approved by all the members present.

Having no more matters to be discussed, Mr. Alma Morquianos moved for the adjournment of the meeting duly seconded by Ms. Annaliza R. Luna. The meeting was adjourned at 11:30 in the morning.
