

1. Presentation of the Status of the Organization

The assembly meeting was formally started at exactly 7:00 o'clock in the evening with Mr. Virgilio D. Modina led the opening prayer, followed by the singing of national anthem led by Ms. Norma O. Escobia. Afterwhich Mr. Edwin M. Perserga suggested that and iterate we still have enough funds to buy seedlings for the production or we will asked from the LGU an assistance for the vegetable seeds for the production of vegetable and it was agreed by everybody.

2. Temporary Appointment of New Secretary, and Treasurer

The Presiding Officer informed the body last December 20 2021, the Officers had an emergency meeting to replace Mr. Ilde E. Lopez as Secretary who has been tendering its resignation last May 2021, we immediately filled -up the position of the Secretary inorder the continuance our planned activities, our new member, Mr. Reynaldo S.
