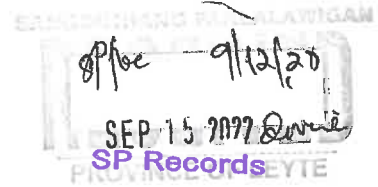

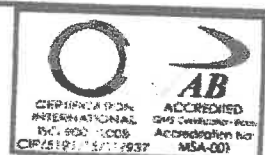



WHEREAS, to ensure the success and sustainability of said Project it was agreed that both parties shall jointly undertake the Project under the following considerations:


