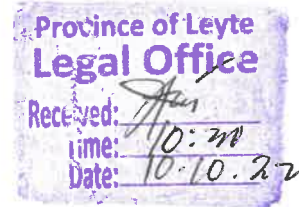

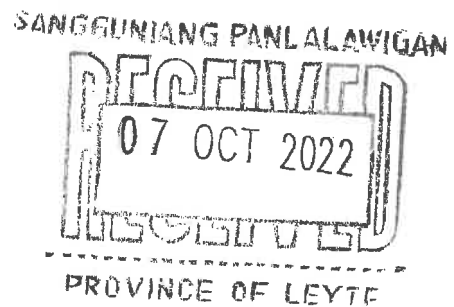

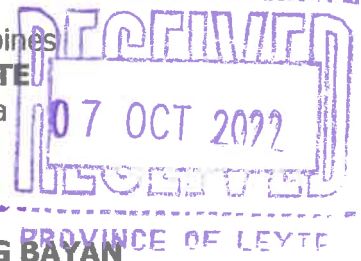

MUNICIPAL ORDINANCE NO. 2022-29

AN ORDINANCE CREATING THE POSITIONS OF TWO (2) PLUMBER 1, WITH A SALARY GRADE 3 (ITEM NO. 01/97 AND ITEM NO. 01/98) AT THE OFFICE OF THE ECONOMIC ENTERPRISE AND APPROPRIATING THE FUNDS NEEDED THEREOF.

NOW THEREFORE, be it ordained by the Sangguniang Bayan of Julita, Leyte in session assembled that:

Section 1. Title

This shall be known as an Ordinance Creating the Positions of two (2) Plumber I with a Salary Grade 3 (Item No. 01/97 and Item No. 01/98) at the Office of the Economic Enterprise and Appropriating the Funds Needed Thereof.

Section 2. New Plantilla Position.

Section 3. Qualification Standard

- . Education : Elementary School Graduate
- . Training : None Required
- . Experience: None Required
- . Eligibility : MC 11 s. 96 Cat. II

Section 4. Qualifications, Power and Duties/Responsibilities

The qualifications, powers, duties and responsibilities of the herein enumerated position shall be based on the provisions of the Local Government Code of 1991 and Civil Service Commission (CSC) and other relevant laws.

Section 5. Appointments

The appointment on who will be occupying the herein mentioned positions shall be within the prescribed qualifications standards and guidelines set by the Civil Service Commission (CSC) and other relevant laws.

Section 6. Funding Support.

The newly-created positions are made part and integral element of the Plantilla of the Local Government Unit of Julita, Leyte and shall be automatically funded from the Personal Services component of the budget of the municipality

Section 7. Repealing Clause.

All previous ordinances and issuances inconsistent with this Ordinance are deemed amended or repealed.

Section 8. Effectivity.

This Ordinance shall take effect after the final review of the members of the Sangguniang Panlalawigan of Leyte and the requirement of posting is complied with.
