

## AN ORDINANCE INSTITUTIONALIZING ARBOR DAY IN THE MUNICIPALITY OF LA PAZ

BE IT ORDAINED, AS IT IS HEREBY ORDAINED by the Sangguniang Bayan of the Municipality of La Paz, Leyte, in session duly assembled, that:

SECTION 1. TITLE. This Ordinance shall be known as the "Arbor Day Ordinance of La Paz, Leyte".

SECTION 2. DECLARATION OF MUNICIPAL ARBOR DAY. The Municipality of La Paz hereby declares the third Friday of August every year, as the Town's Arbor Day.

#### SECTION 3. GENERAL PROVISIONS.

- A. The Local Government of La Paz, all barangays, accredited non-government organizations (NGOs), People's Organization, public and private schools, national government agencies, private sector shall initiate tree planting activities during the Arbor Day of the Municipality of La Paz.
- The different Departments of the Local Government of La Paz, Non-Government Organization, Schools (Elementary to College), all Barangays, Municipal Scholar, shall be required to participate every year during the Arbor Day Celebration at the designated area(s).
  - The La Paz Municipal Agriculture Office shall identify the areas to be covered by the fruit bearing tree planting activity and the seedlings to be planted.
- All La Paznons at the age of twelve and above shall have the responsibility to plant a fruit bearing tree every year.
- E. Fruit Bearing Tree planting activity shall be preferably in:
  - a.) Public or private grounds;
  - b.) Idle or vacant public lands;
  - Public parks; and
  - d.) Private parks and lands with the consent of the owner.

SECTION 4. ARBOR DAY COMMITTEE. A Committee is hereby created which shall be composed of the following:

## SECTION 5. FUNCTIONS OF THE ARBOR DAY COMMITTEE:

- Formulate plans and programs necessary to achieve the intent of this ordinance;
- b) Specify the areas to be planted with fruit trees;
- Monitor and record the activities and projects undertaken under the ordinance; c)
- d) Monitor and evaluate the different sectors on their tree planting activities;
- Give award/ credit to the sector/ group that the most tree that lived; e)
- Identify century and heritage trees.

SECTION 6. MAINTENANCE AND PROTECTION. The maintenance and protection of the planted seedlings shall be the responsibility of the barangay in every fruit bearing tree planting activity.

SECTION 7. ESTABLISHMENT OF A NURSERY. The Municipal Agriculture office shall establish a seedling nursery for the effective implementation of this Ordinance.

SECTION 8. FUNDING. The funds needed for the effective implementation and sustainability of the tree planting activities shall come from any available shall funds and the town's Annual Development Plan under the Municipal Agriculture Office.

SECTION 9. SEPARABILITY CLAUSE. The provisions of this ordinance shall hereby separate and in the event one or more of such provisions are held unconstitutional, the validity of other provisions shall not be affected thereby.

SECTION 10. REPEALING CLAUSE. Any existing ordinance or any of its provision/s which are inconsistent with this ordinance shall be deemed repealed, amended or modified accordingly.

SECTION 11. EFFECTIVITY. This Ordinance shall take effect upon approval and publication in a newspaper of local circulation.
