**AN ORDINANCE PRESCRIBING NEW TRICYCLE FARE RATES 2022 OF THE MUNICIPALITY OF MATAG-OB, LEYTE.**

Be it ordained by the Sangguniang Bayan of Matag-ob, Leyte, in regular session assembled, that:

**Section 1. Title** - This ordinance shall be known as AN ORDINANCE PRESCRIBING NEW TRICYCLE FARE RATES 2022 OF THE MUNICIPALITY OF MATAG-OB, LEYTE

**Section 2. Definition of Terms.** – as used in this ordinance, the following terms are hereby defined as follows:

a) Tricycle for Hire – is a motor vehicle composed of a motorcycle fitted with a single-wheel side car or a motorcycle with a two-wheel cab operated to render transport services to the general public for a fee;

b) Fare Rate – the price charged to transport a person

**Section 3.** All tricycle Operators/Drivers are required to adhere to the herein approved prescribed fare, as per consultation and approval by the Matag-ob Tricycle Drivers Association.

**Section 4. Conditions for Fare.** The driver/operator can charge no more than what is provided for in this ordinance. Fares should also be subject to the following conditions:

- a. A Senior Citizen with I.D. is entitled to the fare discount as reflected herein.
- b. A Student with valid ID shall likewise be entitled to the fare discount as reflected herein.
- c. PWDs shall also be entitled to the fare discount as reflected herein.
- d. Children 7 years old below shall not be charged fare unless the child has occupied a seat.

Violation of any conditions mentioned in this Section is a ground to cancel the franchise granted to the driver/operator besides the administrative penalties hereinafter provided.

**Section 5. Posting of Fare Matrix.** This schedule of rates shall be posted inside the sidecar particularly in the middle portion of the windshield so as to ensure that it is in full view of the passenger.

**Section 6. Fare Rate Increase.** The fare rates is subject to change as the Sangguniang Bayan may deem necessary or upon petition of the operators/drivers.

**Section 7. Conditions for Fare Rate Increase.** The Sangguniang Bayan through its Committee on Infrastructure and Public Utilities, Housing, Land Use and Informal Settlers may hear a petition for fare adjustment depending on the world supply of oil and other economic factors subject to the concurrence or approval of the Sangguniang Bayan.

**Section 8. Penalty Clause.** Any operator/driver found violating any provision of this ordinance shall be penalized as follows:

First Offense	– a fine of P500.00;
Second Offense	– a fine of P1,000.00;
Third Offense	– a fine of P2,000.00, and suspension of MTOP for 30 days.

**Section 9. Separability Clause.** Should any part of this ordinance shall be declared unconstitutional by any court of law, the provisions which are not affected hereby remain in full force and effect.

**Section 10. Repealing Clause.** All existing ordinances, resolutions, rules and regulations, or parts thereof in conflict with or inconsistent with any provision of this ordinance are hereby repealed, amended or modified accordingly.

**Section 11. Effectivity Clause.** This ordinance shall take effect after fifteen (15) days upon approval.
