

AN ORDINANCE AMENDING CERTAIN PROVISIONS MUNICIPAL ORDINANCE NO. 101 s. 2019, ENTITLED: AN ORDINANCE PRESCRIBING FEES AND CHARGES FOR THE USE OF THE MUNICIPAL GYMNASIUM AND SENIOR CITIZENS BUILDING OF MATAG-OB, LEYTE."

Section 1. Section 3. DEFINITION OF TERMS of Municipal Ordinance No. 101 s. 2019 shall be amended to read as follows:

The term housekeeping fee shall be added as letter (d.) and shall mean as follow:

d. Housekeeping Fee - means the fees associated with having the property cleaned following use of property. The said fee shall be used to pay for wages of Utility Worker who shall be incharge in maintaining the cleanliness and orderliness of the Municipal Gymnasium and the Senior Citizens Building while in used during night time or on weekends;

Section 3. DEFINITION OF TERMS. - The following terms, when used in this ordinance shall mean as follows:

- a. Amenities sound system, wall fan, lights
- b. Day covers the time from 6A.M. to 6P.M.
- c. Night covers the time from 6:01P.M. to 6A.M.
