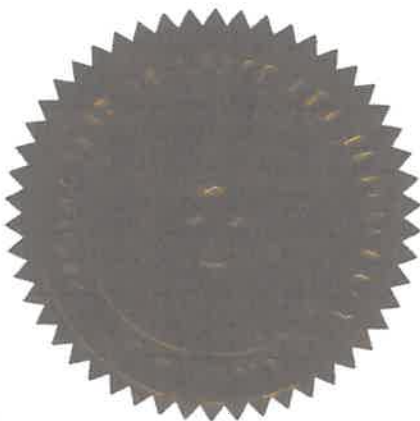

WHEREAS, the DDNFA has a total 20 members and all are residence of the Barangays with the municipality of Hindang;


