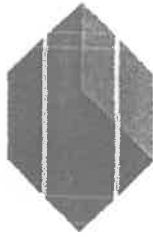

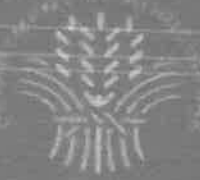



2. To cooperate eventually assume the operation and maintenance of the irrigation system or a portion thereof under such terms and condition that the national irrigation administration (NIA) Board may impose.
3. To serve as a channel for the government and private agencies in providing technical and financial assistance and other essential services concerning irrigated agriculture.
4. To act as a catalyser for payment of loans , land amortization, or for outright sale of farm produce to predetermined buyer, as well as in distribution of farm supplies intended for farmers and to facilitate similar farm transactions between the farmers and concerned parties.
5. To encourage participation of the farmers - irrigators on promoting wholesome community life.
6. To promote continues group action / cooperation thereby enhancing the execution of farm activities to benefits the water users.
7. To implement planned thrift and savings program among its members and initiate fund rising activities for irrigators Association I.A capital build-up.
8. To promote the conduct of continuing and trainings program for IA members / officers part of the development process and
9. To cooperate or federate with similar association to spearhead the growth and development process of cooperative.
