



Gentlemen and Ladies:

Pursuant to the provisions of the Local Government Code of 1991 (Republic Act No. 7160), our preliminary review of the General Fund Supplemental Budget No. 1 FY 2022 of the Municipality of Pastrana, Leyte duly enacted by the Sangguniang Bayan through Appropriation Ordinance No. 001, \$ 2022 with a total appropriation in the amount of P27,727,926.50 reveals compliance with the same law and its implementing Rules and Regulations.

It is therefore recommended for approval subject to the following conditions:

- 1. That the reversion of appropriations is duly authorized by the concerned officials and is backed up by cash collections and are made available to support the expenditures under Supplemental Budget No. 01;
- 2. That the procurement of Civil Works, Goods, Supplies, Equipment, and other related services shall be made in accordance with the provisions of RA 9184 and its Implementing Rules and Regulations;
- 3. That the projects to utilize the 20% Development Fund (DF) shall be in accordance with DBM-DILG Joint Memorandum Circular No. 2020-1 dated November 4, 2020 which will redound to the attainment of desirable socioeconomic development and environmental management outcomes of the LGU:
- 4. That the creation of additional positions shall be in accordance to the minimum standards and guidelines prescribed by the Civil Service Commission (CSC);
- 5. That the grant of Terminal Leave Benefits shall be subject to the provisions of Budget Circular No. 2016-2 dated March 29, 2016;
- 6. That the grant of Hazard Pay shall be based on the conditions enumerated under the Magna Carta for Public Health Workers and payment shall likewise strictly adhere to the said requirements;
- 7. That the grant of Overtime Pay shall be pursuant to CSC & DBM Joint Circular No. 1, s. 2015; and

8. That disbursement of funds shall be for the specific purpose(s) for which they have been appropriated pursuant to Sections 335 & 336 of RA 7160.

Compliance with CSC rules, DBM issuances, and all other accounting and auditing rules and regulations shall be the responsibility of the implementing Local Government Unit.





- WHEREAS, Executive Order 138 issued by President Rodrigo Roa Duterte provides for the full devolution of certain functions of the Executive Branch to the Local Government Units (LGUs) as well as the creation of a Committee on Devolution in consonance with the Supreme Court ruling in Mandanas et al. case;
- **WHEREAS,** the Committee on Devolution has decided to recommend for the creation of the following positions and incorporate the same to the Organizational Structure of the Local Government Unit of Pastrana, Leyte;
- **WHEREAS**, such new positions to be created will be responsive to the needs of the Local Government Unit of Pastrana and that the same has sufficient funds to finance said positions;
- **WHEREFORE,** on motion of Hon. Elvira Bohol, duly seconded by Hon. Nathan Letrodo.

Be it enacted by the Sangguniang Bayan in session assembled that:

ARTICLE I. TITLE. This Ordinance shall be known as an Ordinance Creating New Positions in the Organizational Structure of the Municipality of Pastrana, Province of Leyte and Appropriating Funds thereof.

ARTICLE II. PURPOSE. New positions under the Municipal Mayor.

Section 1. The position of Local Disaster Risk Reduction Management Officer II with salary grade 15 is hereby created;

Declaration of Quorum and Call to Order

The MDC Secretary Engr. Juvilla D. Sy requested everyone to rise for the Opening Prayer and the Philippine National Anthem played through an Audio Visual Presentation (AVP).

Nathan Letrodo as the new member of the MDC council likewise the SB Member, Committee on Finance to give a message. Hon. Letrodo then delivered his short message citing gratitude to the members of the council and he emphasizes to work together for the development and progress of the municipality.

<u>Presentation of Agenda of the MDC Meeting</u>

The MDC Chairperson requested the MDC Secretary to present to the body the agenda of the meeting. Then the MDC Secretary presented the agenda as follows:

She explained that the NTA Reserved Fund is for the newly created mandatory positions as reflected in the Devolution Transition Plan which supposedly to be included during the preparation of the Annual Budget for F.Y. 2022, but the creation of the said plantilla positions were not immediately responded by the former set of the legislative body. She also added that the actual savings for the Personal Services for year 2021 are taken from those mandatory positions that are funded but still vacant namely the Mun. Treasurer, Mun. Agriculturist and the Mun. Accountant. The Mun. Budget Officer likewise explained the other sources of fund for the supplemental budget which were taken from the reversion of 20% Development Fund of the previous year's programs and projects.
