#### **RESOLUTION NO. 2022-304**

A RESOLUTION DISMISSING THE ADMINISTRATIVE COMPLAINT FILED BY ROMEO R. GARRIDO AGAINST SANGGUNIANG BAYAN MEMBER ALDRIN P. AZORES OF JARO, LEYTE.

**WHEREAS,** submitted to the Sangguniang Panlalawigan on June 17, 2022 is a Committee Report of the SP Blue Ribbon Committee, to wit:

#### **"COMMITTEE REPORT**

Referred to this committee on June 7, 2021 per SP Resolution No. 2021-327, is an Administrative Complaint filed by MR. ROMEO R. GARRIDO before the Office of the Ombudsman Visayas, docketed as IC-OV-20-0075, against HON. ALDRIN P. AZORES, a Sangguniang Bayan Member of Jaro, Leyte, for Grave Misconduct and Violation of Section 4 of Republic Act No. 6713.

Respondent Azores filed his Verified Answer last July 21, 2021refuting the charges against him with attached Affidavit of Witnesses executed by Noel A. Castillano and Rey Pore Aure, both in support of the defense of the respondent. An Affidavit of Desistance and Recantation of Complainant Romeo R. Garrido was likewise attached.

Complainant Garrido was summoned by the Sangguniang Panlalawigan on July 30, 2021 per SP Resolution No. 2021-427 for confirmation of his signature on the Affidavit of Desistance and Recantation.

Complainant failed to appear before the Sangguniang Panlalawigan until after another Order was issued dated January 7, 2022 directing the complainant to comment on the verified answer of the respondent and/or confirm his signature on the Affidavit of Desistance and Recantation.

Complainant, together with his counsel, appeared before the Chairman of this committee on June 9, 2022 and confirmed that indeed it is his signature appearing on the Affidavit of Desistance and Recantation.

Premises considered, the committee hereby recommends for the dismissal of this case.
