A Sixty-Twenty-Twenty (60-20-20) sharing scheme were practiced. Sixty percent (60%) of sharing goes to the members duty in the production of and marketing. The Forty Percent (40%) goes to the association, (20% goes to the operational fund and 20% shared by members for the CBU or Capital Build Up).
