

Gentlemen and Ladies:

Pursuant to the provisions of the Local Government Code of 1991 (Republic Act No. 7160), our preliminary review of the General Fund Supplemental Budget No. 04 FY 2022 of the Municipality of Burauen, Leyte duly enacted by the Sangguniang Bayan through Appropriation Ordinance No. 22-04 with a total appropriation in the amount of P635,847.97 reveals compliance with the same law and its implementing Rules and Regulations.

It is therefore recommended for approval subject to the following conditions:

- 1. That the monetization of leave credits shall be pursuant to Budget Circular No. 2016-2 dated March 29, 2016;
- 2. That disbursement of funds shall be for the specific purpose(s) for which they have been appropriated pursuant to Sections 335 & 336 of RA 7160.





Section 1. 
