

CITY ORDINANCE NO. 05, S-2022 10TH Regular Session

"AN ORDINANCE ESTABLISHING A COUNCIL FOR SENIOR CITIZENS AND PERSONS WITH DISABILITIES (PWD) IN THE CITY OF BAYBAY AND APPROPRIATING FUNDS THEREOF"

Sponsored by: Hon. Jose Rommel A. Peñaranda

WHÉREAS, pursuant to Republic Act No. 9994 (the Expanded Senior Citizens Act of 2010), amplifying the constitutional mandate of giving primacy to the elderly and persons with disabilities, as among the priority groups in the provisions of social services, necessitates the mandatory execution of the General Appropriations Act institutionalizing the provision of agency budgets, including local government units, for plans, programs, projects, and activities intended for Senior Citizens and Persons with Disabilities (PWDs)

WHEREAS, Section 458(a)(5)(xvii) of the Local Government Code or Republic Act No. 7160 mandates the establishment of a City Council for the elderly which shall formulate policies and adopt measures mutually beneficial to the elderly and to the community, provide incentives to non-governmental agencies and entities promoting the welfare of the elderly, and, subject to availability of funds, appropriate funds to support the programs and projects for the benefit of the elderly;

WHEREAS, DILG Memorandum Circular No. 20-14-59 encourages all Local Chief Executives to establish a City Council for the elderly and PWDs which shall formulate policies and adopt measures mutually beneficial to the interest and welfare of the elderly, PWDs and the community;

WHEREAS, Senior Citizen and Persons with Disabilities (PWD) Council aims to improve their welfare through participation in the formulation of plans and programs that would promote and enhance their welfare;

NOW, THEREFORE, BE IT ORDAINED, as it is hereby ordained by the *Sangguniang Panlungsod* of the City of Baybay, Province of Leyte, in its Regular Session duly assembled that:

Section 1. TITLE. This Ordinance shall be known as the SENIOR CITIZENS AND PERSONS WITH DISABILITIES COUNCIL OF THE CITY OF BAYBAY.

Section 2. COMPOSITION. The Council shall be composed of the following:

Chairperson: City Mayor

Vice-Chairperson: City Vice Mayor

Members

Chairperson Committee on Social Welfare & Poverty Alleviation

Chairperson, Special Committee on Senior Citizens

Chairperson, SP Committee on Women

Section 3. FUNCTIONS OF THE COUNCIL. The Council shall have the following duties and responsibilities, to wit:

To recommend policies and measures mutually beneficial to the Senior 1. Citizens and Persons with Disabilities (PWD)

2. Subject to availability of funds, prepare a budget to support programs, projects, and other concerns or needs of the Senior Citizens and PWDs

To establish and support the operation of centers or facilities for Senior 3. Citizens and PWDs

To establish a mechanism whereby the contributions of the Senior Citizens 4. and PWDs are maximized in accordance with their respective talents, skills, and expertise.

To perform such other duties and functions as may be prescribed by laws and 5. relevant ordinances.

Section 4. MEETINGS AND QUORUM. The Council shall meet at least once every quarter or as necessary upon the call of the Chairperson. The affirmative vote of the majority of the members of the Council shall be necessary to adopt policies, projects, and programs.

Section 5. COMPENSATION AND REMUNERATION. The Chairperson, Vice-Chairperson and the Members of the Council shall receive no compensation or remuneration in the performance of their duties and responsibilities.

Section 6. FUNDING ALLOCATION. Subject to the availability of funds, a certain amount to be determined by the City Mayor shall be allocated for the Council to be taken from the annual budget of the City set aside for Senior Citizens and PWDs.

Section 7. SEPARABILITY CLAUSE - If for any reason, any section of this Ordinance shall be held unconstitutional or invalid, other sections which are not affected thereby shall continue to be in full force and effect.

Section 8. REPEALING CLAUSE - All ordinances, rules, and regulations or parts thereof in conflict with this Ordinance are hereby repealed, provided that the rights that are vested upon the effectivity of this Ordinance shall not be impaired.

Section 9. EFFECTIVITY CLAUSE - This ordinance shall take effect fifteen (15) days after its publication in a newspaper of general circulation in the City.




