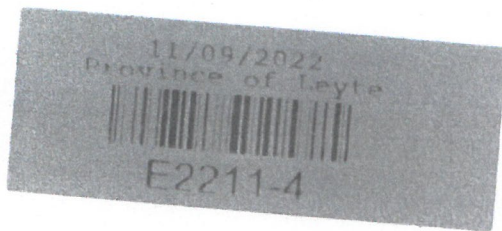

RESOLUTION NO.2022-11-093

RESOLUTION EARNESTLY REQUESTING THE HONORABLE STEVE CHIONGBIAN SOLON, REPRESENTATIVE OF THE LONE DISTRICT OF SARANGANI, TO PASS A BILL FOR THE CREATION OF THE MORO MANDATORY REPRESENTATIVE IN THE LOCAL GOVERNMENT UNITS OUTSIDE THE BANGSAMORO AUTONOMOUS REGION IN MUSLIM MINDANAO (BARMM)

WHEREAS, Section 3 (b) and (h) of RA 7160 states that, *there shall be established in every local government unit an accountable, efficient and dynamic organizational structure and operating mechanism to meet the priority needs and service requirements of its communities, and a continuing mechanism to enhance local autonomy not only by legislative enabling acts but also by administrative and organizational reforms;*

WHEREAS, Presidential Decree No.1083, known as the Code of Muslim Personal Laws of the Philippines states that, *it is the intense desire of the New Society to strengthen all the ethnolinguistic communities in the Philippines within the context of their respective ways of life in order to bring about a cumulative result satisfying the requirements of national solidarity and social justice;*

WHEREAS, in order to ensure the protection of the rights and to craft appropriate sustainable programs for the wellbeing of the Bangsamoro people in parts where they are minority, their participation in the Local legislative body is significant;

WHEREAS, numerous Moro people residing outside the jurisdiction of BARMM should be given equal attention that is tailored-fit to their needs and necessities;

WHEREAS, there is a need to have a Bangsamoro Mandatory Representative in the Local Government Units outside the Bangsamoro Autonomous Region in Muslim Mindanao (BARMM) in order to have an equal representation of Moro people in the different parts of the country particularly in Mindanao.

NOW, THEREFORE

Be it resolved by the Sangguniang Panlalawigan of the Province of Sarangani, to **earnestly request the Honorable Steve Chiongbian Solon, Representative of the Lone District of Sarangani, to pass a Bill for the Creation of the Moro Mandatory Representative in the Local Government Units outside the Bangsamoro Autonomous Region in Muslim Mindanao (BARMM).**

Resolved finally, to furnish copies of this resolution to the Office of the Hon. Steve Chiongbian Solon, Representative of the Lone District of Sarangani, for information and appropriate action and to all provinces of the Philippines for their support.
