655 government. The Bureau of Finance is saying that the 10% entrance fee should be given  
656 to the province of Leyte while the gross income of the Amusement Tax of the cockpit  
657 should be for the Local Government Unit. So, my understanding is that there is a  
658 difference in interpretation of the ordinance. Like for example, in the municipality of Julita,  
659 they use Property Tax. Actually, the Property Tax, it is a tax being loaded by the Province  
660 of Leyte, but the Property Tax being referred to the municipality of Julita is different from  
661 the Real Property Tax which is being mentioned by the Local Government Code and by  
662 the legal department. So, I am in agreement with the Honorable Caña that the opinion be  
663 referred to the legal office so that the LGU of Julita and the legal department can come  
664 into terms to make little changes on the proposed ordinance, Mr. Chair.
